**ORDINANCE 495**

**AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF WORMLEYSBURG, CUMBERLAND COUNTY, PENNSYLVANIA, FIXING THE TAX RATE FOR THE FISCAL YEAR 2012 TO INCLUDE A TAX FOR GENERAL PURPOSES AND A FIRE TAX, PROVIDING FOR A DISCOUNT TO TAX PAYERS WHO MAKE A PAYMENT OF THE GENERAL TAX AND FIRE TAX CHARGED AGAINST THEM WITHIN TWO (2) MONTHS AFTER THE DATE OF THE TAX NOTICE AND PROVIDING A PENALTY OF TEN (10%) PERCENT AGAINST THEM FOR FOUR (4) MONTHS AFTER THE DATE OF THE TAX NOTICE (AS REFERENCED IN THE CODE OF ORDINANCES, CHAPTER 24, and PART 1).**

**BE IT ENACTED AND ORDAINED**, by the Borough Council of the Borough of Wormleysburg, Cumberland County, Pennsylvania, pursuant to the Pennsylvania Borough Code, as follows:

**Section 1.** That a tax is and the same is hereby levied on all real property within the Borough of Wormleysburg and subject to taxation for Borough purposes for the fiscal year 2012 as follows:

“The tax for general purposes, the sum of two and 64/100 (2.64) mils for each dollar of assessed valuation of real property within the Borough of Wormleysburg, Cumberland County, Pennsylvania.”

**Section 2.** That a tax is and the same is hereby levied on all real property within the Borough of Wormleysburg and subject to taxation for Borough fire services pursuant to section 1302 (6) of the Pennsylvania Borough Code for the fiscal year 2012 as follows:

“ The tax for fire protection purposes, the sum of 425/1000 (0.425) mil for each dollar of assessed valuation of real property within the Borough of Wormleysburg, Cumberland County, Pennsylvania.”

**SECTION 3.** All taxpayers subject to the taxes levied and assessed pursuant to this ordinance shall be entitled to a discount of two (2%) percent of the amount of said tax

upon making payment of the whole amount thereof within two (2) months after the date of the tax notice. All taxpayers who fail to make payment of such tax charged against them for a period of four (4) months after the date of the tax notice shall be charged a penalty of ten (10%) percent, which penalty shall be added to the taxes by the tax collector and collected by him or her.

**Section 4.** All Ordinances or parts of any Ordinance in conflict herewith are hereby repealed.

**BE IT ENACTED AND ORDAINED, BY THE** Borough Council of the Borough of Wormleysburg into law this 13<sup>th</sup> day of December, 2011.
