

**ORDINANCE NO. 506**

**AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF WORMLEYSBURG, CUMBERLAND COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15 OF THE CODE OF ORDINANCES OF THE BOROUGH OF WORMLEYSBURG ENTITLED “MOTOR VEHICLES” TO MODIFY PART 7 ENTITLED “SNOW AND ICE EMERGENCY” SECTION 703 ENTITLED “SNOW EMERGENCY ROUTES DESIGNATED”**

**WHEREAS**, Section 1202 of the Borough Code (8 Pa.C.S.A. § 1202) gives Borough Council the power to regulate streets and make regulations as may be necessary for the health, safety, and general welfare of the residents of the Borough; and

**WHEREAS**, the Borough Council of the Borough of Wormleysburg has determined that it is in its best interest and general welfare to designate a greater number of snow emergency routes; and

**WHEREAS**, the Borough Council of the Borough of Wormleysburg deems it to be in the best interest and for the general welfare of the citizens and residents of the Borough to amend Chapter 15 of the Code of Ordinances of the Borough of Wormleysburg to include such aforementioned designations in Part 7.

**NOW THEREFORE, BE IT ENACTED AND ORDAINED** by the Mayor and Borough Council of the Borough of Wormleysburg, Cumberland County, Pennsylvania, and it is enacted and ordained as follows:

**SECTION I:** Chapter 15 of the Code of the Borough of Wormleysburg entitled “Motor Vehicles,” Part 7 entitled “Snow and Ice Emergency,” section 703 entitled “Snow Emergency Routes Designated” is hereby amended and shall read as follows:

**§15-703. Snow Emergency Routes Designated.**

The following are snow emergency routes, which will become active when the combined accumulation of snow and ice reaches six (6) inches:

<b>Street</b>	<b>Side</b>	<b>Between</b>
Yverdon Drive	Both	Entire length
Rupley Road	Both	From Yverdon Drive to Yverdon Drive
West Foxcroft Drive	Both	From Poplar Church Road to Echo Road

Echo Road	Both	From West Foxcroft Drive to Rupley Road
Market Street	Both	Entire length
South Second Street	East side	From Poplar Street to Ferry Street
Poplar Street	Both	From South Second Street to South Front Street
Ferry Street	Both	From South Second Street to South Front Street

**SECTION II:** SAVINGS CLAUSE. In all other respects, the Code of Ordinances of the Borough of Wormleysburg shall remain as heretofore enacted, ordained and amended.

**SECTION III:** SEVERABILITY. The provisions of this Ordinance are declared to be severable, and if any section, subsection, sentence, clause or part thereof is, for any reason, held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of any remaining sections, subsections, sentences, clauses or part of this ordinance.

**SECTION IV:** REPEALER. All provisions of previous Ordinances of the Borough of Wormleysburg which are contrary to this Ordinance are expressly repealed.

**SECTION V:** EFFECTIVE DATE. This Ordinance shall be effective immediately.
