The Monthly Business Meeting of the West Shore Regional Police Department Commission was held at 510 Herman Ave, Lemoyne, PA and called to order at 5:00 p.m. by Commissioner Martini with Commissioner Panko leading the Pledge of Allegiance.

APPROVAL OF MINUTES:

Motion:

Commissioner Preble made a motion to approve the Minutes of the June 6, 2016 Monthly Business Meeting that were previously distributed, seconded by Commissioner Panko. The motion passed unanimously.

TREASURER'S REPORT:

Commissioner Preble reported balances of \$266,769.92 in the checking account, \$279,187.22 in the Money Market Account, and \$18,038.51 in the checking donation account and \$35,158.88 in the K9 donation account as of June 30, 2016.

Motion:

Commissioner Preble made a motion to approve the June 2016 Treasurer's Report and to submit it for audit, seconded by Commissioner Beasley. The motion passed unanimously.

Commissioner Preble made a motion to accept the rental agreement between Lemoyne Borough and West Shore Regional Police Department, seconded by Commissioner Beasley. The motion passed unanimously.

Chairman Martini and Commissioner Panko gave an overview of their pension review meeting with Norm Laporte.

Motion:

Commissioner Panko made a motion to accept the recommendations made by Norm Laporte regarding changing the portfolio to 65% stocks, 30% bonds and 5% cash with an emphasis on stocks that are Large Growth US Stocks, seconded by Commissioner Preble. The motion passed unanimously.

NEW BUSINESS:

There was no new business.

The public meeting was reconvened at 5:54 p.m.

Motion:

The side agreement is regarding the Officer handling extra duties that will be required, seconded by Commissioner Panko. The motion passed unanimously.
